### **Trustees approve contracts** for VATRE, update plans

The Rains ISD Board of Trustees approved contracts and updates during the regular meeting on Monday, October 13.

During the meeting, the board was presented with a contract for election services from the Rains County Election office. The contract would be for the voter approved tax rate election to be held on November 4 and was unanimously approved.

Trustees unanimously approved an updated Rains ISD District Improvement Plan for 2025-2026 and the Rains ISD Multi-Hazard Emergency Operations Plan.

The board took no action on an inter-local agreement for law enforcement with Rains County as it was not

ready.

In his report to the board, Superintendent Joe Nicks informed the board that plans are being developed for replacement of older HVAC units in the district. He stated that there are 237 units with 165 over 15 years old and 63 over 25 years old.

Board members reviewed the Texas Association of School Board's (TASB) Fall Legal Seminars and heard updates on the Texas Legislature from Dennis Glenn of Region 7 Education Service

Trustee Jim Mack Taylor was not present for the regular meeting.

The next regular meeting of the Board of Trustees of Rains ISD is scheduled for Monday, November 10, at 6:30 p.m. in the Alexander Board Room of the Rains ISD Administration Building.

Fallon said that she and Baldwin had even planned a European trip because she thought she was going to get better. However, she developed pneumonia that her immune system was too weak to heal.

### Commissioners accept resignation, approve deputy raises

The Rains County Commissioners Court held a regular meeting on Thursday, October 9, to accept the resignation of Rains County Treasurer Jennifer Trevino and raise pay for Rains County

During the meeting, the court unanimously accepted the resignation of Trevino. She had been appointed to fill the unexpired term of Teresa Northcutt on November 27.

Trevino resigned to take another job, but will remain the county treasurer until a successor is appointed by the court. The office of Rains County Treasurer will be up for election in 2026.

In another item on the agenda, the commissioners addressed a proposal to raise the pay for deputies with funds from Texas Senate Bill 22. In the proposal, Rains County Sheriff Michael Hopkins was excluded from the raises. The proposal, which were retroactive to

October 1, was unanimously approved.

The court approved the purchase of a module from Kologik Software to integrate all law enforcement software in the county. The cost to the county will be \$2,500 with a \$1,000 annual fee.

After a proclamation was read to the court by representatives of Women in Need of Hunt County, the commissioners court unanimously approved the resolution setting October as Domestic Violence Awareness Month.

Commissioners approved the replat of lot 15 in Peg's Retreat, an agreement with CyberScout for IT monitoring services, the fourth quarter invoice for Statewide Automated Victim Notification System (SAVNS) and Rains County Judge Brent Hilliard as the authorized official to sign documents for the SAVNS.

The court tabled a contract with Waste Connections Lone Star for a 30vard roll-off container until it could be

### Early voting for constitutional amendments, VATRE, Point Council starts Monday

Early voting in the November 4 election will start on Monday, October 20, at the Rains County Election office in the Rains County Courthouse Annex at 220 W Quitman St.

Starting Monday, polls will be open for early voting from 8:00 a.m. to 5:00 p.m. each weekday through Friday, October 24 and Monday, October 27, through Wednesday, October 29.

Hours for early voting will be extended to 7:00 a.m. through 7:00 p.m on Thursday, October 30, and Friday, October 31.

In local races, most county residents will vote to decide on a tax rate increase for the Rains ISD school district that will increase revenue to the district as compared to last year. It will be the fourth time that the VATRE has been placed before voters for approval with the first three proposals not receiving enough votes to pass.

Voters in the City of Point will choose a mayor and representatives for Seats 2, 4 and 5 on the Point City Council. The lone contested race has Becky Decker and Kimberly Blissette Hall vying for Place 5 on the council while Angela Nelson, Ray Lacy and Kimberly Berg will run unopposed for mayor, Place 2 and Place 4, respectively.

In the statewide election, residents will vote to approve or disapprove 17

amendments to the Texas Constitution.

Applications for ballots by mail must be received no later than the close of business on Friday, October 24.

On Tuesday, November 4, eight polling locations throughout Rains County will be open from 7:00 a.m. to 7:00 p.m for registered voters to cast a ballot in the general election.

Rains County residents will be able to cast a ballot at eight voting precincts throughout the county including:

The young lady also has a busy life out- known each other for six years starting off



She initiated the "High School Art in the Gallery Competition" in 2015. During a recent art show 15 schools entered the competition that was held at Winnsboro Center for the Arts. She also wrote for the Community Chronicle in Winnsboro for many years. Her family believes that her proudest accomplishment was the co-founding of the local chapter of Dolly Parton's Imagination Library that helped spread the joy of reading to children under five years old. Her grantwriting experience helped her to obtain grants for the program. For her tireless efforts she was honored as Rains County Citizen of the Year in 2022.

Baldwin was an educator for 42 years. She began her career at the age of 19 in Louisville, Kentucky at the Catholic School Diocese. in the obituary She had 60 hours of elemen-located on page 6.

tary education and agreed to teach and take 10 more college hours a semester. She received her undergraduate degree in elementary education from the University of Louisville, Kentucky in 1973 and master's in instructional technology in 1983.

After retiring from teaching in 2002, she subbed at Rains ISD and spearheaded a federal program in Coppell called Service Learning. Her favorite year of teaching was in 1995, in Topeka, Kansas, where she taught seventh and eighth graders radio and television. She worked directly with the local media who ended up donating used cameras and equipment to the school and televisions in all the classrooms. The students presented news every morning. In 1996, Baldwin was named Teacher of the Year for her area of the state of Kansas, and she was one of five finalists for Kansas Teacher of the Year.



### Country Cookin' by any other name

I've been doing a lot of cooking lately - A LOT! We've hosted several home groups in the last couple of

months, I've helped on a 'meal trains" for families with a new baby or some illness that has incapaci-

cook, I contributed couple of dishes to a funeral lunch, and I fixed lunch for my Aunt Fay and two of my cousins, Penny and Bobby. I'm pretty confident of my skills in the kitchen, although I do have a colossal failure now and then, but I was a little nervous about cooking for my aunt who has cooked most of her 101

When our guests arrived, I took a break from last minute preparations to give them a tour of the house. Then, while the guys settled in around David's computer. the rest of us returned to the kitchen with Aunt Fay and Penny on bar stools on the eating side of the island and me on the business side. I was finishing the mashed potatoes with an old-fashioned potato masher instead of an electric mixer, and that was good for a few minutes of conversation. And when I poured a little bit of salt in the palm of my hand before adding it to the potatoes,

Aunt Fay smiled. "I like the way you measure," she said, and we talked a little bit about the progression from recipes and measuring implements to experience and measuring by touch and taste. The meal was a success, and I haven't had to cook much since then. Like most southern cooks, I don't want anyone to leave my table hungry, so I usually make twice as much as I need. It's a good thing I married a man who likes

and recipes reminded me of a column I wrote in the spring of 2014 called "Haute Cuisine or Country Cookin." In it I talk about how I learned that the biggest differences in the two are the names and a little bacon grease. Read it, and see if you agree.

Last week David and I were introduced to Poke Salat or Pokeweed when several bags of it appeared on the "share table" at the Senior Center. At this time of the year, people bring excess produce from their gardens to share with friends. The first time I remember hearing about Poke Salat was when Elvis sang "Poke Salat Annie," but the first time I saw it was last week.

The conversation that day was how to cook the "poisonous" weed to make it edible. I heard one lady say her mother boiled it seven times and poured off the water before she considered it safe. Everyone agreed that it was a tasty treat, but I wasn't sure if it was worth the risk, so I Googled it. I found that, while the purple berries and roots are toxic, if the leaves are young and don't have any tinges of purple, they are not toxic. I found a recipe that said to parboil once, pour off the water, and then finish by either boiling or frying. That sounded easy enough, so I took a small bagful home.

The thing about greens is that a small bagful cooks down to a very small serving, so I added some mustard greens from my garden. I washed, chopped, boiled, and drained. Then, I finished the process by boiling them in a little chicken broth with a liberal mixture of spices thrown in. David judged the results to be quite tasty, and neither of us suffered any ill

This week, more greens appeared on the share table. There was a large box of turnip greens and another of

All the talk about country tender greens – and there was a huge bag of poke salat. I didn't hesitate to get a larger bag of poke, and at the encouragement of the gentleman who brought them, I added a generous portion of the tender greens. There was even more enthusiastic sharing of recipes than last week. and the consensus was that the best way to serve poke, after the requisite parboiling, was to fry it in some bacon grease and then scramble it with some eggs. That sounds an awful lot like spinach quiche which I love, so poke and eggs is on the menu for this weekend.

The comparison between the quiche and its country cousin reminded me of other similarities I've noticed between the Julia Childs and the Granny Hagan version of some of my favorite foods. I thought Quiche Lorraine sounded really exotic until I discovered it was bacon and eggs fancied up a bit. It took me a while to realize that sautéing was simply frying in a little oil at a low temperature, and that most sauces are fancy names for gravy. A roux is simply flour and oil, the base for every good Southern gravy, and espagnole sauce is brown gravy while béchamel sauce is white gravy. I guess if you say it in French, you can charge more, but a croque monsieur is still a fried ham and cheese sandwich.

Regardless of what you call it, though, people love food. We celebrate the joys of life with cake and other goodies, we gather as families and friends over shared meals, and we console one another with casseroles and covered dishes. Whether it's haute cuisine or country cooking, food draws us together like few other things do.

And of all the monsters that lurk in the dark, few are scarier than Sometimes werewolves. known by other names dogmen, wolfmen, man wolves, and Skinwalkers, they are truly the stuff of nightmares. Are they real? You be the judge.

I recently stumbled upon a dusty paperback book that had been tucked away in a forgotten box along with some of my other belongings. If you enjoy true terror and stay awake at night, this book is worth reading and perhaps sharing with friends. The book is entitled, Real Wolfmen- True Encounters in Modern America, written by Linda S. Godfrey. Contained in the book are allegedly true accounts of werewolf sightings and encounters throughout North America. At this time of year, it seems appropriate to share some of these stories with you, my dutiful and fearless readers.

One of the most fascinating accounts in the book involves the repeated werewolf sightings near the town of Elkhorn, Wisconsin. The story gained enough traction to warrant a special segment that aired on the CBS program Inside Edition several years ago. You can watch it looked angry and ran at him

canine-like creature crouching on the side of local Bray Road as she drove home from work late one night in 1989. She said it appeared to be kneeling with a dead animal held in its paws, apparently eating roadkill. Two years later, high school student Doris Gipson was driving on the same Bray Road when she heard a thump and thought she'd hit some kind of animal. Stopping her car to check, she was startled to see a large creature charge at her from out of a nearby cornfield. She said it was larger than a dog, with brown hair and pointed ears, and it was running upright on two legs. Doris jumped back into her car and sped off with the animal in pursuit. It got close enough to scratch the back of her vehicle with its claws. Other area residents reported sightings of the wolf-like creature and werewolf mania

Elkhorn. While Elkhorn seems to be a hot spot in Wisconsin for werewolf sightings, the book outlines dozens of reports from other parts of the U.S. as well.

Many of these reports refer to incidents in Michigan, where tales of "dogmen" are often heard. One incident took place on Fish Creek Road just outside of Holly, Michigan in June of 2005. Jeff Cornelius was driving a tow truck and working as a "repo" man when he drove into a maintenance yard late one night. As he hopped out of his truck, he heard a noise and noticed an upright creature covered with gray and black fur growling at him from about 25 yards away. He said it

as soon as he made eye contact. Cornelius dove back in his truck and raced out of there, getting a good look at the creature in his headlights before it vanished into the night. He described the monster as having pointed ears and a stooped posture with its hindlegs bent backwards. "The only way I can describe it is, it looked like a

werewolf," he said. Werewolf stories from other states abound in this book. Multiple accounts from New York, Maine, Maryland, Alabama, and Kentucky can be found in the pages. There were no reported sightings in Texas, but there have been some in Oklahoma.

Late one night in the fall of 1981, on a rural stretch of Highway 3 between Atoka and Antlers Oklahoma, two friends got the shock of their lives. About five miles from the historic Muddy Boggy Bridge, illuminated in the headlights of their 1972 Ford Maverick, they saw a standing figure on the right side of the road. They estimated that it stood about seven feet high, with short black fur and pointed ears, like a wolf. As they approached, the creature dashed across the road, dropping to all fours as it ran into the darkness. At the next gas station, the men had to stop and change their

### Can You Get a Lump Sum Social Security Payment?

Dear Savvy Senior, I've read that the Social Security Administration offers



a lump-sum payment to new retirees who

extra cash. I haven't yet filed for mv retirement benefits and would like to find out if this is true. What can you tell

me? Born In 1958 Dear 1958,

There is indeed a littleknown Social Security claiming strategy that's been around for many years that can provide retirees a lumpsum benefit, but you need to be past your full retirement age to be eligible, and there are financial drawbacks you need to be aware of too.

First, let's review the basics. Remember that while workers can begin drawing their Social Security retirement benefits anytime between ages 62 and 70, full retirement age is 66 and 8 months for those born in 1958, but it rises in twomonth increments every birth year to age 67 for those born in 1960 and later.

At full retirement age, you are entitled to 100 percent of your benefits. But if you claim earlier, your benefits will be reduced by 5 to 6.66 percent every year you start before your full retirement age. While if you delay taking your benefits beyond your full retirement age, you'll get 8 percent more each year until age 70.

### Lump Sum Option

If you are past full retirement age, and have not yet filed for your benefits, the be taxable, and a lump-sum Social Security Administra- payment could boost the tion offers a retroactive amount of benefits that are sum payment

worth six months of benefits. Here's how it works. Let's say for example that you were planning to delay taking your Social Security benefits past your full retirement age of 66 and 8 months, but you changed your mind at 67 and two months. You could then claim a lump-sum payment equal to those six months of benefits. So, for instance, if your full retirement age benefit was \$2,500 month, you would be entitled to a \$15,000 lump sum payment.

If you decided at age 67 that you wanted to file retroactively, you'd get only four months' worth of benefits in your lump sum, because SSA rules prohibit you from claiming benefits that pre-date your full retirement age.

### Drawbacks

The downside to this strategy is that once you accept a lump-sum payment, vou'll lose the delayed retirement credits you've accrued, and your future monthly retirement benefit will be reduced to reflect the amount you already received. It will also affect your future survivor benefit your spouse or other eligible family members after

you die.

You may also need to Uncle Depending on your income, Social Security benefits may taxed

The federal government taxes up to 50 percent of Social Security benefits at ordinary income tax rates if your combined income – defined as adjusted gross income plus nontaxable interest income plus half of your Social Security benefits - exceeds \$25,000, and up to 85 percent of benefits are taxable if combined income exceeds \$34,000. For married couples, the comparable income thresholds for taxing benefits are \$32,000 and \$44,000.

To help you calculate this, see IRS Publication 915 'Social Security and Equivalent Railroad Retirement Benefits" at IRS.gov/pub/irspdf/p915.pdf, or call 800-829-3676 and ask them to mail you a copy.

In addition, if the lumpsum payment of retroactive Social Security benefits boosts your yearly income over \$106,000 (or \$212,000 for married couples filing jointly), it will increase your future Medicare premiums too. See Medicare.gov/Pubs/ pdf/11579-medicare-costs.pdf for details.

### Redistricting attracts a spate of GOP candidates

Redrawing the state's congressional maps, though being challenged in court, has drawn 114 Republican candidates in the state's 38

Texas Legislature redrew the maps at the request of President Donald Trump in hopes of gaining five additional GOP seats. As a result, there are winnable seats for Republicans in Houston, San Antonio and Dallas that have drawn 19 GOP candidates to

date. Two Republican members of Congress are seeking statewide office instead of trying to hold on to their current seats. Chip Roy, who represents a Central Texas district, is running for Texas attorney general, while Houston Republican Wesley Hunt recently jumped into the U.S. Senate race.

In addition, Michael McCaul, R-Austin, and Morgan Luttrell, R-Houston, are not seeking reelection. Those four open seats have drawn 25 GOP candidates.

#### Company tapped to run school voucher program

A New York tech company has been picked to administer the state's new school choice program, the Texas Standard reported. The billion-dollar program passed in the regular legislative session will help parents use taxpayer money to pay for private school tuition, homeschooling expenses, and other educational expenses.

Odyssey, the company, manages education funding in several other states. It will be responsible for both processing applications and ranking families to determine who gets access to funding.

Anyone can apply as long as they have a child eligible to go to public school in K-12 as well as 4-year-olds who are eligible for prekindergarten.

Odyssey can receive up to 5 percent of the total school

choice appropriation of \$1 billion, meaning it could earn up to \$50 million for administering the voucher program.

#### Roberson's execution date paused by Texas court

lust a week before his scheduled execution date, the Texas Court of Criminal Appeals stayed the execution of Robert Roberson in the death of his two-year-old daughter in 2002. Roberson was convicted of capital murder the following year for shaken baby syndrome, a diagnosis since discredited by most scientists. His case has drawn widespread attention

and calls for his exoneration. The Austin American-Statesman reported that the state's highest criminal court decided to send the case back to trial in Anderson County, where he was convicted. The court cited the case of Andrew Wayne Roark, a North Texas man who was exonerated in a similar "shaken baby syndrome" case.

One of the judges wrote a concurring opinion: "As identified in Roark, our scientific understanding of what has become known as Shaken Baby Syndrome has significantly advanced. Because of this deeper understanding, certain assumptions and conclusions that were once thought to be true may not be."

Roberson, now 58, claims his daughter fell out of the bed in the middle of the night in 2002. He soothed her to sleep, and upon checking on her later that night, found that she was not breathing. She was pronounced dead at an emergency room the next day, and Roberson was eventually charged and convicted of capital murder.

### Cornyn, Paxton neckand-neck, poll finds

A poll published last week shows incumbent U.S. Sen. John Cornyn and Texas Attorney General Ken Paxton essentially tied, with new entrant U.S. Rep. Wesley Hunt not far behind, according to the Express-News. His entry suggests that no candidate is on track to win an outright majority, making a runoff likely—at least at this

The poll by the University

of Houston and Texas Southern University, conducted the last two weeks of September, found 34 percent of respondents favored Paxton to 33 percent for Cornyn. Hunt picked up 22 percent of poll respondents with 11 percent of likely GOP voters polled still undecided.

Trump has yet to weigh in on the race, with all three candidates eager to receive his endorsement, if one is forthcoming. The poll found that half the respondents would vote for any candidate Trump endorsed.

#### Abbott directs DPS to increase hemp enforcement


Gov. Greg Abbott has directed the Texas Department of Public Safety to toughen enforcement against vape and smoke shops that don't comply with new state regulations that prohibit selling hemp-de-

rived products to minors. Abbott issued an executive order to keep shops from selling hemp-derived products to minors after attempts to either ban such products outright or impose new laws regulating sales failed in the last two special sessions.

"Texas will protect children from dangerous hemp products," Abbott said.

DPS will conduct targeted operations to identify vape and smoke shops that could be selling to minors. The effort will include conducting undercover investigations.

### FISHING REPORT

The Texas Parks and Wildlife Department released the following information for Fork and Lake Tawakoni taken on October

Fork: Good. Normal stain; 84 degrees; 1.64 feet below pool. Bass are good with yellow magic and buzzbait topwaters around grass, and rage swimmers around grass in 1-4 feet of water. Carolina rigs are good on points and tree lines in 10-12 feet of water. Bass are fair with deep long points. Shad patterned small hand tied jigs are also baits are best.

Black Bass are beginning to school in open water. Fly fish with small top water patterns. Cooler nights will drop water temperatures and bass will move shallower. Streamers are enticing bass early and late. Bream are shallow, try small hoppers. Sandbass are

schooling mid-lake.

Lake Fork crappie fishing is getting better and better as we head into fall. Fish are beginning to stack up and feed well. Black crappie are loading up at the base of trees, some brush piles, underwater bridges and we should see them on bridges soon. Look for those fish in 13-22 feet of water. White crappie are loading up on trees and brush piles in 13-32 feet and should be moving towards the dam and deeper water soon. Minproducing. We have had good luck with larger minnows threaded onto 1/16 ounce jig heads for white crappie on timber. Soft plastics should also get you bit as water temperatures drop down.

**Tawakoni:** Good. Water lightly stained; 80 degrees; 1.03 feet below pool. Lake

Tawakoni continues to fish well as we begin to see the first signs of the lake turning into some fall patterns. The hybrid striper and white bass bite are good. The fish are moving hard looking for good pockets of water. Fish main lake points in 8-15 feet using inline spinners and slab spoons. The eating sized catfish bite is still red hot. Easy limits on half day trips are the standard right now. Baited holes in 12-20 feet using prepared baits such as punch or dip crankbaits in 22-25 feet on nows are working well and baits. The trophy blue catfish are beginning to feed. We have seen fish in the 20-30 pound range on medium sized pieces of cut baits in 10-25 feet. Crappie are improving under bridges and on shallow brush with the bite on minnows. Largemouth bass are extremely shallow and preferring fast moving shallow





The Rains Wildcat football team started fast, but the Mount Vernon Tigers stormed back to win the District 7-3A-1 contest, 64-19, on Friday night,

October 10. The Wildcats jumped out to an early 12-0 lead, but allowed 57 unanswered points to the Tigers.

Senior Nate Scott provided some excitement late in the game as he returned a kickoff 83 yards for a touch-

The Rains offense was held in check as they managed 78 yards rushing and 126 yards passing. The Tiger offense gashed the Wildcat defense for 509 yards in the

Senior Taisean Shields led the team in rushing with 15 carries for 80 yards and two touchdowns, while junior Jabari Shields was held to two yards on eight carries.

Sophomore Major Wallace started at quarterback and completed four passes for 46 yards. He continued to

for 80 vards

When J. Shields was behind center, Wallace shifted to the slot and caught two passes for 39 yards. Freshman Cooper Combs caught a pass for 41 yards.

On the defensive side of the ball, senior Kenneth Griffith finished with ten tackles to lead the team, while senior Jordan Hobbs and freshman Christopher Montano finished with four tackles each.

### Cooler weather = Active Catfish

Many people think of catching catfish as a summertime endeavor but some of the best blue catfish action begins about this time of the

year when water temperatures begin to fall. While the red hot 'big fish' trophy catching will peak in a few

weeks water temperature falls into the sixties, lots of eater size fish weighing between 4 and 15 pounds, with an occasional trophy class fish are currently being landed. I've noted that the bite usually turns on around the time of the Harvest Moon each year.

I'm recently off a red-hot trip with Lake Tawakoni catfish guide Tony Pennebaker and we found the blues to be right on schedule. We didn't catch any trophy fish. Tony knows Ole' Luke much prefers catching a good 'mess' of eater size blues than trophy hunting for Mount Vernon kept their trophy class catfish. But with a big fish. I'll tell you about the trip in a bit but first, a bit of information on blue catfish seasonal pat-

> Trophy class blue catfish are landed throughout the year, even during the heat of summer. But the majority of big fish are landed during the fall and winter months. With the onset of warm weather in late spring, many 'catters' target the smaller channel catfish over holes baited with soured grain or cattle range cubes, but it's often common to catch mixed stringers of both channels and smaller blues using punch bait. From now until spring, fresh bait such as cut shad, pieces of rough fish such as carp or buffalo will be the go to bait for serious catfish anglers.

The fall blue catfish bite green algae (moss) in the fish occurs something like this each year. First, the eater size blues turn on (currently underway). During this period lots of blues destined for the fish fryer are landed. It only takes a few fish weighing 4 to 10 pounds to make for a jumbo size fish fry! Granted, trophy class fish weighing upwards of 25 pounds can be landed anytime fresh bait is in the water, but prime time for trophy hunting is still a few weeks away. Through the cold weather months trophy hunters are rigging with stout circle hooks, 30-pound plus line, stout rods and high line capacity reel, baiting with chunks of fresh shad, the oiler and bloodier the better. Contrary to what many folks think, not all fish are landed from deep water, even during the coldest of weather. Some of the very best big fish action of the winter occurs a day or two after a hard freeze. The quickly dropping water temperature causes a major shad die off and the steady day or two of wind that often

There was a hint of fall in the early morning air as Tony eased his big guide boat out of the harbor at Tawakoni Marina. The long sleeves on my fishing shirt felt good as we headed to Tony's first fishing area. A flock of teal buzzed overhead, one of the first of waterfowl to migrate each fall. In a few weeks, cormorants will help point the way to feeding catfish. The fish eating birds roost by the thousands in standing timber and point the way to some great winter catfish action. The catfish are there to feed not only on the bird's droppings but the algae that grow sub surface on the trees. I learned this from Tony a few years ago when we found

at the cleaning table. Tony in convinced the vegetation grows well on the roost trees because of the natural fertilizer in the bird's droppings.

Tony used two methods on this trip. We began with Santee Cooper rigs near bottom, baited with fresh shad, and later slow trolled using the trolling motor to slowly pull planer boards behind the boat. This method covers lots of water and is a great way to catch fish that are scattered rather than in tight schools. Early in the morning we boated several fish up to 10 pounds using the stationary baits and about mid morning, we began slow trolling. Tony set out five rods, two with planer boards on either side of the boat and one directly behind the boat. The planer boards pull the baits out from the boat so the lines won't get tangled and also present the baits in a wide area behind the boat.

We were fishing relatively shallow water and a glance at the side imaging sonar showed the area was holding follows a cold front pushes lots of catfish. But they were scattered and not in tight shallows at three feet or less. schools, a perfect scenario

for trolling.

After about four hours of catching, we returned to the cleaning table at Lake Tawakoni Marina and Tony transformed our catch into three gallons of snow white fillets, some of the best eating in freshwater, in my opinion. I stopped by Bucee's before the trip and grabbed a bag of ice for my cooler. I've fished with Tony many times and knew to think ahead, I wanted to ice those fillets as soon as possible.
