Charges against Franklin dropped; Wallace trial set for Dec. 8

Felony charges against Rains County Justice of the Peace Robert Jenkins Franklin were dropped during court proceedings held Friday morning, November 21, in the Rains County Courthouse. Franklin pleaded guilty to disorderly conduct, display of a firearm, a misdemeanor crime.

Franklin was arrested in May 2025 on two felony charges and two misdemeanor charges. According to a grand jury indictment, one indictment ac-

cused Franklin of pressuring an employee who worked for him to testify falsely in a February 2025 official proceeding, and the second indictment, stemming from October 2023, accused Franklin of coercing a prospective witness in a criminal case to give false testi-

The misdemeanor charges stem from those dates as well.

Franklin was charged with disorderly conduct, display of a firearm, after public outcry surrounded an online post showing him standing near a courthouse window holding a gun.

Franklin pleaded guilty to the class B misdemeanor and was sentenced to 12 months of deferred adjudication.

District Attorney Pro Tem Tonda Curry, the District Attorney for Van Zandt County, told Judge Chris Martin of the 294th District Court, who presided over the proceedings, that she believed the probable cause was true and correct; however, through further investigation, she could not prove it beyond a reasonable doubt. She said that evidence came to light that was not brought before the grand jury.

"It has to do with credibility," Curry

answered when asked why she requested the charges be dismissed following the hearing. "I'm not going to go any further because there is civil litigation pending and - unlike some of the folks following the cases - I don't think cases should be tried on Facebook or YouTube, they should be tried in the court of law."

Regarding the firearm matter, Curry stated that she knew there was a strong public outcry. She then said that Texas law allows a judge or a district attorney

Council approves equipment repairs, amends EDC articles

The East Tawakoni City Council held a regular meeting on Tuesday, November 18, to authorize repairs on water department equipment and amend the Articles of Incorporation for the East Tawakoni Economic Development Corporation (EDC).

During the meeting, East Tawakoni Public Works Director Kyle Washburn presented the council with a quote to repair the diesel engine on a HydroVac Truck. He noted that he had only received one quote but expected several in the coming week.

The equipment uses high-pressure water for non-destructive digging and excavation and is a key piece of equipment for the department. The council unanimously approved a motion to have the engine repaired at the best

Washburn updated the council on repairs to a Ford F-350 pickup used by

the department. The vehicle went to the dealer for a recall repair. While in the shop, other issues were discovered during a routine inspection. He had a quote from the dealership, but ex-

pected more quotes on the repairs soon. As the repairs were not vital, the item was tabled by the council until more quotes could be received.

The council was presented with amendments to the Articles of Incorpo-



The First Thanksgiving Day

THIS WEEK IN TEXAS HISTORY Mexican Rebel fought on both sides

Jose Maria Jesus Carbajal waited until the guards were out of the Matamoros jail on

settlers of San Antonio de Bexar. Jose Carbajal spent much of his youth at boarding schools in the United States before returning to colonial Texas in the late 1820's. From his close friend Stephen F. Austin, he borrowed enough money to live on until the American found

him work. Elected from San Antonio to the Coahuila-Texas legislature in early 1835, Carbajal's criticism of the despot Santa Anna shortened his life expectancy. When a warrant for his arrest was issued that summer, he wisely hightailed it to Louisi-

Carbajal was captured in November off the Texas coast running guns to the rebels. After regaining his freedom and putting his name on the Goliad Declaration of Independence in December 1835, he mysteriously vanished during the climax of the Revolution.

Carbajal briefly surfaced

four years later at the head of

an abortive revolt in northern Mexico. He won a minor skirmish but lost the use of his left arm and once again disappeared. Months went by without a clue to Carbajal's whereabouts, and his many admirers to the north presumed he was dead or in prison.

against foreign invaders. In September 1851, Carbajal appealed for armed assistance in liberating the Mexican borderland, and several hundred Texans answered the call no questions asked. Their leader was the vintage Ranger Rip Ford, who never missed a good

fight. The rebels marched on Matamoros taking the river towns of Camargo and Reynosa on the way. Safe and sound in Brownsville, the frightened inhabitants awaited the outcome of the battle for their sister city which began on Oct. 21.

The next day, Millard Fillmore advised all Americans to keep their noses out of the messy business in Mexico. The president warned would-be adventurers that he would not lift a finger on their behalf, if they were captured south of the border.

Fillmore, in fact, violated his official policy of neutrality in the complicated conflict by secretly supplying the government garrison in Matamoros. Carbajal responded with an open letter declaring, "The Americans who are acting with me will not shame either their country or their name.

On the verge of victory, Carbajal stunned his followers on Oct. 30 by ordering an immediate withdrawal from Matamoros. He realized that seizure of the city would be a short-lived success since his small contingent was certain to be annihilated by enemy reinforcements already on the way.

While Carbajal beat a hasty retreat up the Rio Grande, Rip Ford hurried to Austin in search of fresh recruits. Honored on the spot with an unsolicited seat in the state legislature, he used the position to lobby for his latest cause. But the bad news from Matamoros had taken the fun out of the Imagine their surprise when enterprise, and Rip found he suddenly showed up in

Carbajal and 11 lieutenants quickly posted bail and prepared for another round. The execution of several supporters, including two Americans, revived in the Texan interest

comatose crusade. Carbajalistas staged an overnight raid on Reynosa in March 1853 and held the alcalde for a \$30,000 ransom. Refusing to pay a peso more for the bureaucrat than he was worth, residents made a counter-offer of \$2,000. The bandits took the cash, freed the hostage and

headed for the nearest bar. The American army had no trouble rounding up the drunken raiders. Detained long enough to discourage a repeat performance, the insurrectionists sober

deserted in droves. Jose Carbajal himself soon made the same sensible decision. His fervent beliefs did not blind him to the fact that there was no future in fighting two governments -Mexico and the United States.





Dallas Fed: State's economy is cooling

The Texas economy is cooling, according to a analysis researchers at the Federal Reserve Bank of Dallas. The News reported the analysis concludes that tariffs, inflation and uncertainty about the economy are taking a toll on the state's businesses.

"Tariffs and the surrounding uncertainty continue to impact the Texas economy," Luis Torres, a Dallas Fed economist who coauthored the analysis, said in accompanying comments. He added that nearly half of all the businesses surveyed are seeing costs go up because of tariffs, and more than a fourth are passing along those higher costs to their

Paxton asks court to keep divorce records sealed

Texas Attorney General Ken Paxton is asking a Collin County court to seal records in his ongoing divorce case, The News reported. A hearing has been set for Dec. 19 on a lawsuit filed by several major media companies to make the records public.

"Allegations that might suggest abuse of marital assets, concealment of financial information, or personal conduct inconsistent with public responsibility are not merely private — they are of public consequence," plaintiffs' filing reads.

In response, Paxton called the media companies' efforts an "unprecedentedly broad and intrusive request."

Paxton's wife, state Sen. Angela Paxton, R-McKinney, filed for divorce in July, citing infidelity, according to Collin County court documents. Ken Paxton is attempting to unseat U.S. Sen. John Cornyn in next March's GOP primary.

Add a flu shot to Thanksgiving shopping list

The Texas Department of State Health Services is encouraging everyone to add flu shots to their Thanksgiving shopping lists. Flu vaccines are widely available at health clinics, doctors' offices, and pharmacies across Texas.

"It is especially important for older adults, very young children, people with chronic health conditions and pregnant women to get protection from the flu," said DSHS Commissioner Jennifer Shuford. "People in those higher risk groups are more likely to get seriously sick if they do get the flu, and some will inevitably need to be hospitalized and even die from their infections."

The Centers for Disease Control and Prevention estimates that the flu caused at least 600,000 hospitalizations in the United States and tens of thousands of deaths last flu season. Cooler weather, holiday gatherings, and increased travel all increase the risk that the flu will spread. Public health officials recommend everyone six months of age and older get vacci-

Move over or slow down to protect roadside workers

and other first responders risk their lives every day, and drivers can help keep them safe by always moving over or slowing down.

These individuals are often only inches away from heavy or fast-moving traffic, making them vulnerable to serious injury or death in the event of a crash. That risk to their lives is amplified when people speed or drive distracted.

Expansion of Move Over or Slow Down law

law Texas requires motorists to move over an entire lane or slow to 20 mph below the posted speed limit when approaching law enforcement, tow trucks, utility vehicles, municipal waste trucks, emergencyresponders and TxDOT vehicles with activated overhead lights on the side of the road.

Since Sept. 1, 2025, the law has been expanded to include vehicles driven by animal control officers and enforcement parking employees.

Tips for drivers:

• Be alert and pay attention when approaching roadside law enforcement, first responders, tow trucks, utility service vehicles and TxDOT vehicles with flashing lights on.

When possible, move

• Slow down to 20 mph below the posted speed limit if safely switching lanes is not possible or the road doesn't offer multiple lanes.

• Reduce speed to 5 mph on roadways with a posted speed limit of 25 mph or less. Failure to follow the Move

Over or Slow Down law can result in a fine of up to \$1,250 for a first offense. Drivers who cause serious injuries may face jail time and a fine of up to \$4,000.

FISHING REPORT

The Texas Parks and Department released the following information for Lake Fork and Lake Tawakoni taken on November 12:

normal Fork: Good. stain; 66 degrees; 2.54 feet below pool. There is a good shallow bass bite. around grass on chatterbaits, spinnerbaits and some topwaters. Squarebill crankbaits beds and high spots in 3-6 feet. Carolina rigs are fair on points and road beds 10-12

Black Bass are feeding in the backs of creeks and coves. Cooler nights have dropped water temperatures and bass are cruising the shallows. Streamers are enticing bass early and late in the day. Bream are shallow, try small hoppers. Sand bass are schooling mid-lake.

Crappie are good as the

fish transition to a fall and winter pattern. Fish can be found throughout the lake in 10-40 feet of water. Seeing lots of fish still on brush piles, underwater bridges and shallower trees in 10-20 feet. We also still have fish on some lay downs in big numbers. Also look for fish on timber in 18-40 feet along creek channels, flats and the edge of timber this week on my boat but any crappie baits will get you bit as water temps cool down. We should see fish on mid lake bridges as the fish migrate towards deeper water chasing the bait fish.

Tawakoni: Good. Water lightly stained; 74 degrees; 1.76 feet below pool. Lake Tawakoni has been fishing good as we enter the fall The unseasonably warm temperatures have

slowed the fishing some. Hybrid stripers have been slow this week while the white bass are good. Starting to see a solid open water bite setting up, but with the extreme heat this week the fish pulled back into shallow water. Slabs and swimbaits are working best in 5-10 feet. Eating size catfish is as good as it gets. Daily limits of 1-2 pound channel catfish are good on shallow road lines. Small hand tied jigs can be caught on punch bait actually out fished minnows and dip bait. Trophy blue catfish are picking up in 12-18 feet of water with fresh cut bait. This past week a 42 pound blue catfish and 65 pound yellow catfish were caught. Crappie are good on jigs and minnows under bridges and on timber in 12-16 feet. Largemouth bass are good in 1-4 feet of water on dock legs and riprap with shallow crankbaits, shaky heads and spinnerbaits.

Dear Curious, Recognizing the early signs of Parkinson's disease is challenging because the symptoms are often subtle and/or similar to those in other health conditions, which means they can easily be overlooked, dismissed or misdiagnosed.

Parkinson's disease, which afflicts around 1 million Americans, is a degenerative disorder that occurs when the brain's dopamine-producing neurons die or become impaired. This happens in the part of the brain that controls movement, which can cause tremors, stiffness, and difficulty with walking, balance, and coordination.

The symptoms usually begin gradually and get worse over time, and the progression of symptoms is often different from one person to another. Some people with Parkinson's become severely disabled, while others may experience only minor motor disrup-

While the cause of Parkinson's disease unknown, scientists believe genetics and environmental factors (exposure to certain toxins) play a key role. Most people with Parkinson's first

more likely to develop it than are women.

Early Warning Signs

Parkinson's disease is difficult to diagnose because there's no definitive test to confirm it. Doctors, usually neurologists, will do an examination and evaluate a combination of warning signs, but symptoms can vary greatly by patient which often leads to confusion and misdiagnosis. That said, here are some of the key signs and symptoms everyone should be aware of.

Restless sleeping: Talking in your sleep, sleepwalking and/or acting out your dreams by kicking or jerking. This is a REM sleep behavior disorder and one of the strongest and earliest prediagnostic symptoms Parkinson's disease.

Loss of smell: Not being able to smell certain foods very well like bananas, dill pickles or licorice. This early symptom occurs in around 70 to 90 percent of Parkinson's patients.

Constipation: Problems with digestion and bowel movements are a big problem for people with Parkinson's, and an early sign that can occur up to 20 years

before this disease is diag-

nosed. Changes in handwriting: Writing may become harder to do, and your handwriting may appear much smaller than it has in the past.

Soft voice: According to the Parkinson's Foundation, 89 percent of people with Parkinson's will have speech and voice disorders, which often shows up first in volume of the voice, meaning that you may speak more

Tremors: Slight shaking

develop the disease around or tremor in your finger, age 60 or older, and men are thumb, hand or chin. The tremor usually happens at rest, and when you move the extremity, it may disappear. This is the most common and recognizable outward sign of Parkinson's disease, but by the time tremors start, the brain has already lost more than half of its dopamine-producing cells.

Slowed movement: Over time, Parkinson's disease can slow movements, making simple tasks difficult and time-consuming. Your steps may become shorter when you walk. It may be difficult to get out of a chair. You may drag your feet as you try to walk.

Masked Face: The muscles in the face experience the same gradual stiffening as in the rest of the body, which results in lack of smiling and facial expres-

Impaired posture and balance: Stooping, leaning or slouching when you stand, and/or balance problems can all be an early sign of Parkinson's.

Having these symptoms doesn't necessarily mean that a person has Parkinson's disease. But if you are experiencing any of them, and you're over age 60, you should consider talking with your doctor, who may order a DaT scan or Syn-One (Skin Biopsy) Test to help diagnose it. Early detection leads to earlier treatment, which can improve a person's overall quality of life.



NOTICE OF RATE CHANGE REQUEST

On October 14, 2025, Southwestern Electric Power Company (SWEPCO or Company) filed a Petition and Statement of Intent to Change Rates (the Petition) with the Public Utility Commission of Texas (PUC or the Commission) in Docket No. 58819, and with those municipal authorities in its Texas service territory that have original jurisdiction over SWEPCO's electric rates. This notice is being published in accordance with Section 36.103 of the Public Utility Regulatory Act and Commission Procedural Rule 16 Tex. Admin. Code (TAC) § 22.51(a)(1).

SWEPCO has approximately 191,000 Texas retail customers. All such customers and all classes of customers will be affected by the relief requested in SWEPCO's Petition.

SWEPCO's request to change its rates is based on the financial results for a 12-month test year ending on March 31, 2025. SWEPCO's Petition requests approval for a total Texas retail base rate revenue requirement of \$641,516,844 and a base rate increase of \$163,896,434, an increase of 41.67 % over adjusted Texas retail Test Year base rate revenues exclusive of fuel and rider revenues. The proposed increase in Texas retail revenues will be offset by setting SWEPCO's current TCRF, DCRF, Advanced Metering System (AMS) surcharge, and a portion of Net Operating Loss Carry forward (NOLC) surcharge to zero, a reduction of \$68,960,435. Thus, the net proposed increase is \$94,935,998. The overall impact of the proposed revenue requirement, considering both fuel and non-fuel revenues, is a 13.48% increase. The impact of the rate change on various customer classes will vary from the overall impact described in this notice, as shown in the table below. In addition, SWEPCO is seeking recovery of the reasonable rate-case expenses, including expenses paid to reimburse intervening municipalities, that it incurs in this case and those rate-case expenses incurred in three prior dockets that have yet to be recovered.

A Residential Service customer using 1,000 kilowatt-hours of energy per month will see an increase in their total bill (including fuel costs and rate riders) of \$16.43 per month, an increase of approximately 12.15%.

SWEPCO has proposed that its requested rate change become effective 35 days after the filing of the Petition and Statement of Intent. The proposed effective date is subject to suspension and extension by actions that may be taken by the Commission and other regulatory authorities.

SWEPCO also seeks to reconcile its Advanced Metering System (AMS) deployment costs through March 31, 2025. SWEPCO is requesting to (1) implement new base rates reflecting its ongoing costs to provide AMS and (2) reconcile AMS costs with AMS surcharge revenues under 16 TAC § 25.130. At the conclusion of this proceeding, with the implementation of new base rates, SWEPCO proposes to eliminate the AMS surcharge and roll AMS capital expenditures and AMS operations and maintenance costs into base rates.

SWEPCO is proposing various revisions to most tariffs and schedules. In addition, in order to facilitate future TCRF, DCRF, and Generation Cost Recovery Rider (GCRR) filings pursuant to 16 TAC §§ 25.239, 25.243, and 25.248, respectively, SWEPCO requests that the Commission: (1) set the Company's current TCRF and DCRF to zero; and (2) establish in this docket the baseline values consisting of the inputs to the calculations that will be used to calculate SWEPCO's TCRF, DCRF, and GCRR in future dockets. Persons with questions or who want more information on this Petition may contact SWEPCO at 428 Travis Street, Shreveport, Louisiana 71101, or call toll-free at (888) 216-3523 during normal business hours. A complete copy of the Petition and related filings is available for inspection at the address listed in the previous sentence.

Persons who wish to intervene in or comment upon these proceedings should notify the Commission as soon as possible, as an intervention deadline will be imposed. The deadline for intervention in the proceeding is 45 days after the date the application was filed with the Commission, unless otherwise provided by order of the presiding officer. Hunting camp recipes

Hunting seasons are well underway and chances are good that many of you already have a freezer wellstocked with everything

from venison steaks and ground meat breasts. Let's not let all this meat freezer

week's column. Game meat is far more nutritious than domestic, but it does require different cooking techniques. Take venison, for example. Venison is very lean and what fat there is in the meat should be removed; it's the fat that sometimes contributes to the 'gamey' taste that some folks complain about. I've been eating game meat all my life and learned much of what I know about cooking game from an uncle that was a 'sure nuff' old time Dutch kettle cook. He made a pot of squirrel and dumpling that I have yet to duplicate. No canned biscuits for uncle, he made his dumplings the old-fashioned way by rolling out dough. I can still see that old Dutch kettle sitting on the outside of the campfire coals slow cooking those squirrels. I am often asked if wild hogs are good to eat or "doesn't venison have that 'gamey' taste.?" I've found it impossible to answer these questions with a blanket statement. I often reply with something like this: "If you were going to a hog farm to purchase your pork chops, would you choose the oldest boar? Likewise, you wouldn't choose an older bull for your ribeye steaks! Younger game animals in good condition obviously make better table fare than older ones. This is not to say that venison from older bucks, if prepared steak is better tasting than

properly, is not good eating. I always use the center ham cuts, tenderloins and backstraps for steaks and grind the rest for sausage or, add beef fat to it and make venison burger.

Because of its dry nature. larger cuts of venison must always be cooked with moisture. I've slow cooked many venison hams resulting in a flavorful, tasty piece of meat. Slow cooking at low temperature is the key to preparing roasts from game animals. I usually season the roast well with my favorite dry seasonings and a couple of bay leaves, and using a sharp knife, make incisions into the roast and insert pieces of bacon, slivers of garlic and onion or jalapeno pepper. Then, covered with slices of fatty bacon and a little butter on top, I place the roast in a covered cast iron kettle and bake slowly for about 10 hours at 200 degrees. The meat falls off the bone and is well received at the dinner table when served with carrots, potatoes and onions

(which I add to the roast a couple hours before serving). Making BBQ from these larger cuts is another great way to please a crowd at hunting camp or home. I do a lot of my cooking on an electric smoker and I've found it to be a very easy and carefree method of tenderizing larger, tougher cuts of meat. I simply place the roast in a double layer of heavy duty foil, add BBQ sauce and allow to smoke uncovered a couple hours, using hickory, plum, peach or pecan wood. Then, wrapped in the foil, the roast is allowed to smoke at 190 to 200 degrees for up to 12 hours or so, or overnight. This method makes some of the best tasting, most tender BBQ imaginable. I often smoke cuts of wild hog, which have flavorful fat, with venison and blend the two for chopped BBQ.

the best beef round steak, to my way of thinking. I use a tenderizing mallet and pound the steaks, adding dry seasonings during the process. Then, I cover the steaks with milk and refrigerate several hours before frying. Dipped in an egg batter and dusted with the flour the steaks need only three or four minutes on each side in hot oil. Drain the steaks, chop and sauté an onion in a little of the remaining oil and pour a big can of mushroom soup (with a little water) and you have smothered steak! Put a lid on the cast iron skillet and bake or cook on the stove top over low heat for an hour or so to tenderize. Serve with hot rice and hot dinner rolls.

Quail and dove can be prepared and fried just like chicken. The late Bob Hood, longtime Texas based outdoor writer and great friend, came upon a method for preparing quail that is the best I've found. He places a couple rows of Ritz crackers in a plastic bag and crushes them into a fine meal. Next. in a Dutch oven he melts two sticks of butter, and then coats the quail pieces (or chicken wings) in butter, then covers them with the Ritz meal. Cooked for about 1 hour, the quail are a golden brown. The Ritz meal batter is crunchy and adds a great deal of flavor to the game

If you're new to cooking game and game birds, hopefully these tips will serve as a good place for you to expand your culinary skills. Making great tasting meals from game animals and birds is really no great feat but it does require a bit of common sense and adherence to a few basic rules.
